Our Executive Committee takes pleasure in presenting Annual Report for the year ending 31st March 2011 along with Audited Annual Accounts for the year ended on that date. During the year under review, the following are our achievements.

## **ACTIVITIES & PROGRAMMES**

#### CHILD LABOUR AWARENESS PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. The initiatives and support for the Eradication of Child Labour in India, through the government sector, non-government sector, judiciary, social workers and public at large has raised hopes for creating mass movement against the menace of child labour and provide universal compulsory education for children. Legislation relating to the regulation of child labour concentrates mainly on four basic issues;

- · Minimum age for employment of children,
- · Maximum period of work per day and forbidding work at night
- · Prohibition of certain types of work for children, and
- · Medical examination of all working children.

A Child Labour Technical Advisory Committee has been setup to advise the Central Government in addition of occupations and processes to the schedule contained in the child labour. The committee was empowered to undertake reviews and frame rules as necessary to ensure that the work is regulated in accordance with part.

## **GIRLS EDUCATION PROGRAMME**

The organisation conducted the programme in Patna District of Bihar State. Education especially for women is an important agent of socialization, and instrument of social transformation, and a channel of social mobility and equity. Education of girls and women has to be a universal movement for their empowerment, for changing current stereo-typed and replacing the existing structures.

Within an overall orientation toward girls' education, OUR organisation is running this Programme being one of the parts of overall strategy of universalisation of Elementary Education. This is an alternative path to children who for different reasons cannot attend primary school e.g. girls who have to look after their younger siblings and attend to other domenotic chores, working children etc.

## POOR CHILD EDUCATIONAL PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. Our constitution makers had known that India of their vision would not be a reality if the country's children are not nurtured and educated. Article 24 dealing with prohibition of employment of children in factories and Article 45 relating to provision of free compulsory education for children bear testimony to this realisation. The other prohibition of traffic in human beings and forced labour (Article 23) and certain principles of policy to be followed by the State stipulates that children be secured against exploitation.

Child labour in India is more of a rural than urban phenomenon. Approximately, 90 percent of the working children in the rural areas are employed in agriculture and allied activities. The unorganised and informal sectors, both in urban and informal sectors, both in urban and rural areas, account for almost the entire child labour force.

#### EDUCATIONAL DEVELOPMENT PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. Education is a prime determinant of human development. Progress of a community in education may be viewed from several angles and hence different indices of educational achievement may be used. The conventional indices include (i) effective literacy rate (ii) primary school enrolment rate (iii) drop-out rate at the primary level (iv) mean years of schooling at the primary level (v) pupil- teacher ratio and (vi) distance of schools from place of residence.

#### AIDS AWARENESS PROGRAMME

The organisation conducted the programme in Patna District of Bihar methods adopted, the female Among sterilization predominates as 21.4 percent of the eligible women had unmet need is for spacing birth and the remains for limiting the children. A majority of the male respondents indicated progresses for female method. They did not prefer the male methods mainly because of the fear of weakness due to the was of male method, fear of method failure and fear of operation It was decided to prepare a wide AIDS scheme for the coverage of family planning programme by the society. Local doctors and Para-medical workers have extended their useful co-operation in diffusion of the requisite knowledge about family planes methods to the eligible couples with intrusive comparing in the district.

## **VOCATIONAL TRAINING PROGRAMME**

The organisation conducted the programme in Patna District of Bihar State. Managing committee of the society decided to start vocational training programme for self-employment. That training programme is aims to equip rural youth in the age group 18-35 years with the skills and technology required for self-employment. Society allowed relaxation of age certain special conditions, especially in the case of carpet weavers, lepers, the disabled, pensioners and widows. For develop youth entrepreneurship society choose Home based industries like handicrafts, Beedi industry, Agarbatti making, Tailoring and Garment. Under these programmes society teach & training of rural youth for self-employment during this year under this programme 56 persons benefited and able to self reliance and our society have aims to working increase more than hundred people benefits next year and develop their infrastructure.

## **SANITATION PROGRAMME**

The organisation conducted the programme in Patna District of Bihar State. Communicable diseases continue to be the leading cause of morbidity and mortality in the state of Bihar, especially in the state of Bihar, especially in the flood-prose areas of the Bihar. During the season of monsoon, OUR society organized an awareness

programme Madhubani district. It was primarily aimed to arouse health-consciousness among the people coming from the lower strata of society, in particular Nishads and Mushahars. Our health instructors and activists visited the houses of Nishad and Mushahars of the locality and tried to convince and motivate them to develop some healthy habits and get rid of bed ones to check the communicable diseases. They were given instructions about the importance of cleanliness and sanitation in life. They were convinced that if they want to earn more, and lead a healthy life, they must give proper attention to this aspect too. At this occasion, also people afflicted with different diseases were diagnosed and given essential medicines free of cost.

#### **HEALTH & FAMILY WELFARE PROGRAMME**

The organisation conducted the programme in Patna District of Bihar State. Population stabilization has been a priority area for sustaining the process of economic development in the country. This has been also the focus of successive five-year plans. Bihar lags behind not only in containing population growth to manageable limits but also in realizing the goals fixed on the health front.

As we know that the increased access to equality health care services has been one of the thrust areas of the social development programmes being undertaken in the country. Technological advances and the extension in the infrastructure network has resulted in a decline in mortality. But the burden of disease continues to be important. Our Society organized a series of health camps on a regular basis in different districts of Bihar.

#### WOMEN AWARENESS CAMP

The organisation conducted the programme in Patna District of Bihar State. Entrepreneurship is a process where one person getting himself self employed provides job to others also. The person is called "entrepreneur". He acts as a leader. In India only 8 per cent of the small scale-manufacturing units are run exclusively by women entrepreneurs, which are proportionately very small as compared to other, developed & developing countries. We can see, USA alone, about 50 percent of the business is owned by women.

Various efforts are being made to improve the status of women; women folk have not taken their maximum use & remain still backward. In almost all countries, the Governments are providing special provisions for women's development & efforts are being made to extract maximum use of women's talent.

According to society it is need of time working for make women entrepreneurship and increasing their participation in economic activities. For develop women entrepreneurship society choose Home based industries like handicrafts, Beedi industry, Agarbatti making, Tailoring and Garment. Under these programmes society teach & training by SHGs formed.

### BACKWARD CLASS UPLIFTMENT PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. The school is run for students of Backward and Other Backward classes of the society. The society also imparts free education to 20 students and provides scholarship for meritorious students of the lowest rung of the society on economic ladder. The coaching is run for students of class I-VI.
