ACTIVITIES & PROGRAMME

HEALTH &FAMILY WELFARE PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. Population stabilization has been a priority area for sustaining the process of economic development in the country. This has been also the focus of successive five-year plans. Bihar lags behind not only in



containing population growth to manageable limits but also in realizing the goals fixed on the health front.

As we know that the increased access to equality health care services has been one of the thrust areas of the social development programmes being undertaken in the country. Technological advances and the extension in the infrastructure network has resulted in a decline in mortality. But the burden of disease continues to be important. Our Society organized a series of health camps on a regular basis in different destricts of Bihar.

SOCIAL JUSTICE PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. More concretely, research performed by members of the programme studies how and to what extent particular governance arrangements help or hinder the achievement of goals of social justice. The research programme builds on the strong ISS tradition of research in the areas of politics, public administration, public policy and international law, but is committed to cutting across disciplinary boundaries. The research programme relates organically with the third 'leg' of ISS' activities related to valorization of research, in particular through capacity development activities in the global South.

EDUCATION DEVELOPMENT PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. The programme was organized in Patna Block of Bihar district. The spread of education in a vast country like ours has always been a challenging task. If we talk about education in rural area this figure is very cruel.

The literacy rate in rural areas increased from about 36 per cent in 1981 to 59 percent in 2001. The corresponding rates in urban areas corresponding rates in urban areas were about 67 and 80 percent, respectively, thus rural –urban gap has although declined from about 31 to 21 percentage points but the void is still very wide. So, OUR society decided to organize rural education programme as primarily.

Education is a process of development from the cradle to the grave. Man becomes a gentleman through education and he alone can be educated with the other living organisms are trained. While his life is guaranteed by food, it is glorified by education. However, it is an undeniable fact that no community or society or district or state or nation can prosper without having educated manpower. Education is the most powerful instrument for imparting ideal training to the people.

India today is striving out in to the modern world. We are looking ahead to new technology, to high technology, new types of employment and a new dynamism in our economic growth. But while we look ahead, we must not forget the millions who are below poverty line in our rural areas. We must pay attention to the scenario of education prevailing in rural areas of the country.

want to organize rural education programme for all villagers. OUR society realize that the village based education programme can sustain for larger period of time if the village community based is able to take over its running. Community participation in education in rural areas not only ensures physical and human facilities at schools but also motivates the teachers to achieve higher quality of education. Integrating an income generation component into the education programme may also help a great deal.

SOCIAL AWARENESS PROGRAMME

The organisation conducted the programme in Patna District of Bihar State. The growing social awareness across the globe has brought a number of issues to the fore among which gender equality and empowerment of women are very significant. Discrimination against women in the form of malefemale differentiation constitutes the core of the gender- based system. Gender bias is generated by the process of extending the biological sex differences to the criteria of social placement. The rise in the levels of education, which nourishes progressive outlook, and the advent of industrialization and modernization have effected a sea change in the attitude and thinking patterns of the people. Consequently the idea that women have to be treated on par with men in every respect has gained currency.

Empowerment, as the word suggests, is to empower or enable women to do certain things and in most cases it connotes women wielding political power. A deeper understanding of the word throws light on many of its dimensions and implications. The very concept of empowerment of women which is based on equality between sexes, is a long drawn, conscious and continuous process comprising enhancement of skills, capacity building, gaining self-confidence and meaningful participation in decision making. As the foremost precursor to development, empowerment of women comprehensively seeks to ensure an equitable division of resources and carve a clear role for them in decision-making. It helps them articulate theirs as well as other rights and participate actively in the democratic processes. Empowerment also

wards off retrogressive practices like female infanticide and gender based violence.
